



STABLE RULES

IN ORDER TO MAINTAIN SAFETY TO ALL RIDERS AND HORSES, AS WELL AS MAINTAIN CLEANLINESS THROUGHOUT THE STABLE AND GROUNDS, BLUEBIRD EQUESTRIAN CENTER (BEC) HAS ESTABLISHED THE FOLLOWING RULES TO BE FOLLOWED.

ALL HORSE RIDING AND HANDLING IS DONE AT YOUR OWN RISK!

1. ANYONE WHO RIDES A HORSE MUST **SIGN A WAIVER.**
2. **PLEASE BE SURE TO HAVE ON FILE AT THE STABLE OFFICE.** (1) SIGNED STABLE RULES. (2) A SIGNED BOARDING AND HOLD HARMLESS AGREEMENT.
3. **ASTM/SEI HARD HATS** MUST BE WORN WHEN RIDING. **BOOTS OR RIDING SHOES** WITH HEELS ARE REQUIRED WHEN RIDDING.
4. **SMOKING IS PROHIBITED** ON THE LANDS OF RENDEZVOUS RANCH AND THE FACILITIES OF BLUEBIRD EQUESTRIAN CENTER.
5. **BOARDERS OR GUESTS ARE NOT ALLOWED TO OPERATE ANY BEC MOTORIZED EQUIPMENT.**
6. **BOARDERS PLEASE LEAVE YOUR DOGS AT HOME.** DO NOT BRING YOUR PETS ONTO THE PREMISES.
7. **YOUNG CHILDREN MUST BE UNDER ADULT SUPERVISION AT ALL TIMES.** UNSUPERVISED CHILDREN ARE NOT ALLOWED ON THE PREMISES UNTIL THEY HAVE REACHED THEIR 13th BIRTHDAY.
8. **AN ADULT MUST ACCOMPANY ANY VISITOR UNDER THE AGE OF 18,** UNLESS PRIOR ARRANGEMENTS HAVE BEEN MADE.
9. **IF YOU BRING FRIENDS OR RELATIVES,** THEY MUST BE SUPERVISED AT ALL TIMES AND WILL BE EXPECTED TO FOLLOW ALL THE RULES AND REGULATIONS APPLYING TO THIS FACILITY, FAILURE TO DO SO WILL RESULT IN THEM AND POSSIBLY YOU, BEING ASKED TO LEAVE.
10. **PLEASE ACT CALM AROUND THE HORSES.** NO HORSE PLAY OR IRRESPONSIBLE BEHAVIOR WILL BE TOLLERATED. THIS INCLUDES:
 - NO CLIMBING ON FENCES OR GATES.
 - NO RUNNING.
 - NO BOISTEROUS PLAYING AROUND HORSES.
 - NO YELLING.
11. **WE RECOMMEND THAT HALTERS BE REMOVED FROM HORSES** IN STALLS AND TURNOUT AREAS, IF HALTERS MUST BE LEFT ON, BREAKAWAYS WILL BE REQUIRED.
12. **NO HORSE IS TO BE LEFT UNATTENDED** TIED IN ITS STALL OR ON CROSSTIES.
13. **THERE WILL BE NO RIDING** IN THE STALLS OR HORSE RUNS AT ANY TIME.
14. ALL OWNERS / RIDERS MUST **CLEAN UP** AFTER THEMSELVES. MANURE SHOULD BE DUMPED IN DESIGNATED AREAS ONLY.
15. **IN AN EMERGENCY,** A VET WILL BE CALLED AT YOUR EXPENSE IF YOU CANNOT BE REACHED OR IF YOU FAIL TO TAKE APPROPRIATE MEASURES.
16. **REPORT ANY INJURIES OR REPAIRS** NEEDED FOR THE BARN TO BEC (303) 888-8101.
17. **LOCK THE TACK ROOM** PRIOR TO LEAVING THE PROPERTY IF NO ONE ELSE IS AROUND. ANY LOSS OF EQUIPMENT IS NOT THE RESPONSIBILITY OF BLUEBIRD EQUESTRIAN, ITS MANAGEMENT OR EMPLOYEES.
18. **HELP YOUR FELLOW RIDERS AND BOARDERS.** ALWAYS TRY TO WORK TOGETHER; FIGHTING, GOSSIPING AND GENERAL POOR BEHAVIOR TOWARDS PEOPLE OR HORSES WILL NOT BE TOLERATED.
19. **BE RESPECTFUL** OF OTHER PEOPLE'S PROPERTY.
20. **TURN OFF ALL LIGHTS** WHEN LEAVING.
21. **ANY CONCERNS AND REQUESTS** MUST BE ADDRESSED IN WRITING WITH THE DATE AND YOUR NAME AND PLACED IN THE OFFICE IN THE BARN, OR EMAIL TO john@bluebirdequestrian.com.

YOUR COOPERATION IN RECOGNIZING THE IMPORTANCE OF THESE RULES, AS WELL AS ADHERING TO THEM IS GREATLY APPRECIATED. THE ABOVE RULES ARE SUBJECT TO CHANGE AT THE MANAGEMENT'S DISCRETION.
